THE ROAD TRANSPORT ACT 1987

THE ROAD TRANSPORT (PROVISION OF PARKING PLACES)
(CITY OF KUCHING NORTH) (AMENDMENT) ORDER, 2011

(Made under section 72)

In exercise of the powers conferred by section 72 of the Road Transport Act, 1987 [Act 333], the Commission of the City of Kuching North, being declared an appropriate authority under section 67 of that Act [P. U. (B) 289/92], has made the following Order:

Citation and Commencement

1. This Order may be cited as the **Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 2011**, and shall come into force on the 24th day of March, 2011.

Amendment of Article 8

2. Article 8(2) of the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 2005 [Swk. L.G. 48/2005] (hereinafter referred to as the "Principal Order") is amended by substituting it with the following new paragraph:

"(2) A parking coupon in Form A, Form A1, Form B, Form B1, Form C, Form C1 or Form D, as may be appropriate, in the Third Schedule may be used in respect of any parking place specified in the First and Second Schedules."

Amendment of Article 20

3. Article 20(2) is amended by substituting for the words "any person authorized by the Commission" in line one the words "Commission's agent".

Amendment of Article 27

4. Article 27 is amended by substituting for the words "person authorized by the Commission" in line one the words "Commission's agent".

Amendment of First Schedule

5. The First Schedule is amended —

Amendment of Third Schedule

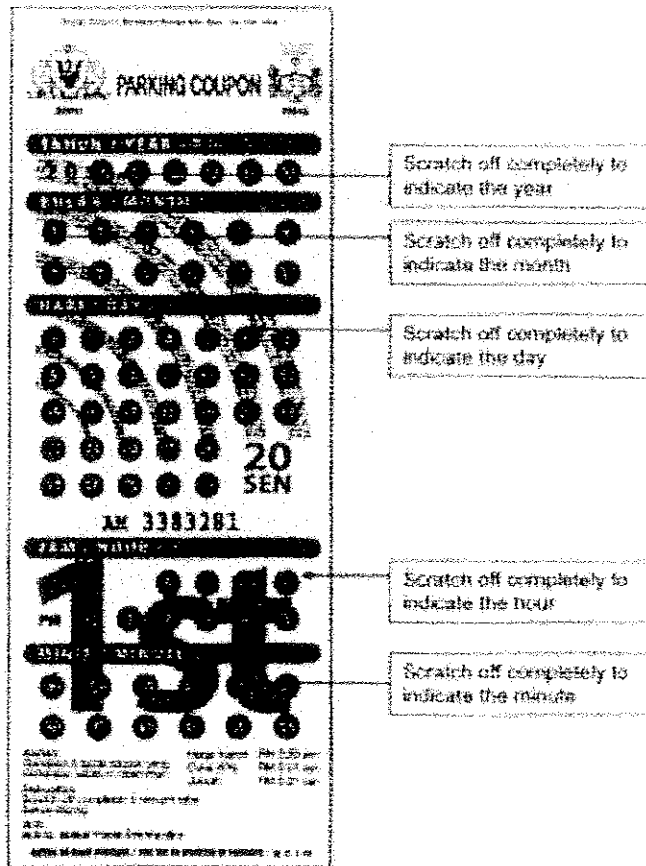
7. The Third Schedule is amended —

- (i) by inserting immediately after Form A the following new Form A1 as follows:

FORM A1

COUPON VALID FOR FIRST HALF HOUR PARKING

1. The date (year, month and day) and time of commencement of parking shall be indicated on the parking coupon by scratching off completely the appropriate tabs.
2. Where two or more parking coupons are displayed, the time of commencement of parking for the second and subsequent coupons shall be immediately after the expiry of parking covered by the previous coupon.

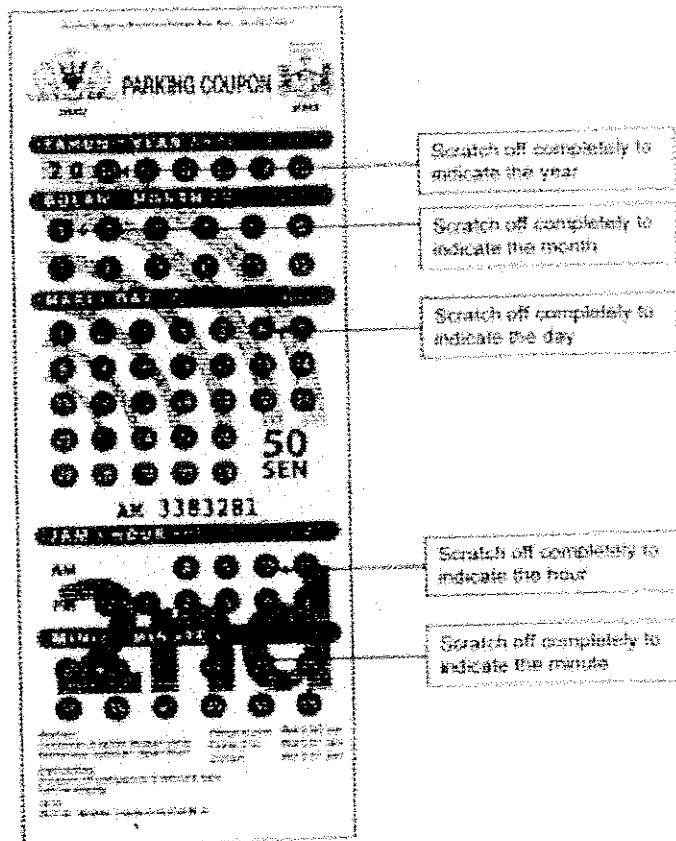


(ii) by inserting immediately after Form B the following new Form B1 as follows:

FORM B1

COUPON VALID FOR SECOND HALF HOUR PARKING

1. The date (year, month and day) and time of commencement of parking shall be indicated on the parking coupon by scratching off completely the appropriate tabs.
2. Where two or more parking coupons are displayed, the time of commencement of parking for the second and subsequent coupons shall be immediately after the expiry of parking covered by the previous coupon.



(iii) as follows: by inserting immediately after Form C the following new Form C1

FORM CI

COUPON VALID FOR THIRD HALF HOUR PARKING AND THEREAFTER

1. The date (year, month and day) and time of commencement of parking shall be indicated on the parking coupon by scratching off completely the appropriate tabs.
2. Where two or more parking coupons are displayed, the time of commencement of parking for the second and subsequent coupons shall be immediately after the expiry of parking covered by the previous coupon.
