## THE KUCHING MUNICIPAL ORDINANCE

THE CITY OF KUCHING NORTH (LICENSING OF  
PREMISES OF LOTTERY AGENCIES) BY-LAWS, 1995

(Made under section 103)

In exercise of the powers conferred by section 103 of the Kuching Municipal Ordinance as extended to apply to the City of Kuching North under section 4 of the City of Kuching Ordinance, 1988, the Majlis Mesyuarat Kerajaan Negeri has made the following By-laws:

1.—(1) These By-laws may be cited as the City of Kuching North (Licensing of Premises of Lottery Agencies) By-laws, 1995, and shall come into force on the 1st day of January, 1996.

(2) These By-laws shall apply only to the area of the City of Kuching North.

Interpretation.

2. In these By-laws—

“area of the City of Kuching North” means the area under the jurisdiction of the Commissioner of the City of Kuching North as described in the Schedule to the City of Kuching North Ordinance, 1988;

“Commissioner” means the Commissioner of the City of Kuching North appointed under the City of Kuching North Ordinance, 1988;

“licensed lottery” means any lottery which is lawfully being promoted or operated under a licence or permit issued pursuant to any law for the time being in force relating to gaming, betting or lotteries.

Prohibition of  
using pre-

3. No person shall use or keep any premises as an agency for the conduct or sale of any licensed lottery except under and in accordance with a licence issued by the Commissioner.

Application,  
and renewal  
of licence.

4. An application for a licence or a renewal thereof shall be made to the Commissioner in such form, and shall be accompanied by such particulars, as the Commissioner may determine.

Form and  
duration of  
licence.

5.—(1) A licence is issued at the discretion of the Commissioner and shall be in such form as may be prescribed and subject to such terms and conditions as the Commissioner may impose.

(2) Every licence shall expire on the 31st day of December of each year and may be renewed for a further period not exceeding one year at a time.

6. The fee for a licence shall be one thousand ringgit per year or part thereof and shall be payable on the issuance or renewal of the licence. Fee.

7. The holder of a licence is not permitted to transfer or assign his licence to another person. Licence not transferable.

8. The licence shall be exhibited at all times in a conspicuous place on the licensed premises. Licence to be exhibited.

9. Any person who contravenes any of the provisions of these By-laws or fails to comply with any condition in a licence shall be guilty of an offence: Penalty, a fine of one thousand ringgit and, in the case of a continuing offence, to a further fine of one hundred ringgit for each day during which the offence continues. Offences and penalties.
