THE ROAD TRANSPORT ACT 1987

THE ROAD TRANSPORT (PROVISION OF PARKING PLACES)
(CITY OF KUCHING NORTH) ORDER, 2005

(Made under section 72)

In exercise of the powers conferred by section 72 of the Road Transport Act 1987 [Act 333], the Commission of the City of Kuching North, being declared an appropriate authority under section 67 of that Act [P.U. (B) 289/92], has made the following Order:

Citation and commencement

1. This Order may be cited as the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 2005, and shall come into force on the 1st day of November, 2005.

Interpretation

2. In this Order—

"Commission" means the Commission of the City of Kuching North or in Bahasa Malaysia "Dewan Bandaraya Kuching Utara" established under section 4 of the City of Kuching North Ordinance, 1988 [Cap. 49];

"goods vehicle" shall have the same meaning as assigned to that expression in the Commercial Vehicles Licensing Board Act 1987 [Act 334];

"motor vehicle" shall have the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"parking" has the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"parking coupon" or "coupon" means coupon or other document issued by the Commission for the purpose of parking a motor vehicle in accordance with article 8;

"parking period" means the period prescribed in the First and Second Schedules during which a motor vehicle is allowed to be parked on payment of the prescribed fee;

"parking place" means any road or place specified in the First and Second Schedules, and includes any place in which the appropriate sign indicates that parking of motor vehicles is permitted;

"parking space" means the space marked out in a parking place for the parking of a motor vehicle;

"parking warden" means any person appointed by the Commission as such, and includes any person authorized by the Commission to perform the duties and to exercise the powers of a parking warden under this Order;

"prescribed fee" means the parking fee prescribed in the First and Second Schedules payable by any person for parking a motor vehicle in a parking place;

"public service vehicle" shall have the same meaning as assigned to that expression in the Commercial Vehicles Licensing Board Act 1987 [Act 334];

"road" has the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"season parking coupon" means the official receipt or any other document issued by the Commission, showing the registration number of a motor vehicle and the amount of the prescribed fee for the parking of such vehicle in a specified season parking place for a period of time specified in such official receipt or document;

"season parking place" means a parking place specified in the Second Schedule, wherein motor vehicles in respect of which a season parking coupon has been purchased may be parked; "sign" means a sign under the Traffic Signs (Size, Colour and Type Rules 1959 [Fed. L.N. 167/59], and includes any sign or notice displayed by the Commission for the purposes of this Order.

Provision for parking places

- 3.—(1) The Commission provides that the roads or places specified in—
 - (a) the First Schedule shall be used as half-hourly parking places; and
 - (b) the Second Schedule shall be used as half-hourly and season parking places,

for motor vehicles, other than public service vehicles or goods vehicles unless otherwise authorized by Commission to park, and the fees to be paid for the use thereof shall be such as are prescribed in the respective Schedules.

- (2) The Commission may, by notification in the Gazette, amend the Schedules specified in paragraph (1).
- (3) Roads or places other than those mentioned in paragraph (1) shall be parking places for the parking of a certain class or description of motor vehicles as the Commission may designate from time to time by the exhibition or erection of the appropriate signs thereat showing, *inter alia*, the class or description of motor vehicles to apply and the prescribed parking fees imposed (if any), and the appropriate provisions of this Order shall apply thereto.
- (4) No person shall park or caused to be parked any motor vehicle on any road except in a parking place provided or designated for the parking of such a motor vehicle.
- (5) No vehicle shall be parked in a parking place where the sign indicates that the parking place is for the use of a certain class or description of vehicle, unless that vehicle belongs to that class or description.

Parking System

- 4.—(1) In providing parking places, the Commission shall, with the approval of the Minister, to determine and implement the types of parking system including coupon parking system and any other systems which it considers suitable and the manner in which they are to be managed, and the provisions of this Order shall apply thereto subject to such modifications as may be considered necessary.
- (2) The Commission may impose any conditions it deems fit in managing such parking places and such conditions shall be observed and complied with by every person intending to use the parking places provided.

Season parking place

- 5.—(1) No person shall park any motor vehicle in any season parking place unless he is in possession of a season parking coupon as set out in Form D in the Third Schedule for such parking place or is duly authorized by the Commission so to park.
- (2) Any person using a season parking place shall display the relevant parking coupon in the same manner as vehicle licence is required to be displayed by rule 18 of the Motor Vehicles (Registration and Licensing) Rules 1959 [Fed. L.N. 173/59], at all times when the motor vehicle is in the season parking place.
- (3) The Commission may at any time withdraw parking facilities from any season parking coupon holder without assigning any reason therefor (in such event, the Commission, if the validity of the unexpired period of the parking coupon is more than fifteen days, refund to the holder of the parking coupon half the sum for which the parking coupon has been issued).
- (4) On the application of a person to whom season parking coupon has been issued, while such season parking coupon is still in force and on the production by him of the season parking coupon and on payment of a fee of five ringgit, the Commission may amend the season parking coupon to enable it to be used in respect of the motor vehicle mentioned in the application instead of the motor vehicle in respect of which the season parking coupon has been issued.
- (5) The holder of any season parking coupon shall inform the Commission whenever his season parking coupon has been lost, destroyed, defaced or the particulars thereon have become illegible, and shall obtain a duplicate thereof (the fee for a duplicate season parking coupon shall be ten ringgit).
- (6) If a motor vehicle is left in a season parking place while a valid season parking coupon is duly exhibited on the motor vehicle but is not removed from the season parking place until after the date of expiry of the season parking coupon, no parking warden shall permit the motor vehicle to be removed from the season parking place until a new valid season parking coupon has been obtained in respect thereof.
- (7) No person shall remove a motor vehicle from a season parking place unless the motor vehicle is duly displaying a valid season parking coupon in respect thereof in accordance with paragraph (2).
- (8) Where a motor vehicle is parked in a season parking place without a valid season parking coupon or had remained in a season parking place after the expiry of the authorized parking period specified in the season parking coupon, it shall be the duty of the parking warden to issue an advice

note to be affixed to the windscreen or any conspicuous part of the motor vehicle requesting the owner of the vehicle to pay the prescribed parking fee and an additional excess charge of one ringgit for every hour or fraction thereof during which the motor vehicle had been parked in a season parking place without a season parking coupon or had remained parked in a season parking place after the expiry of the authorized parking period. Any person who fails to pay such sum shall be guilty of an offence: Penalty, a fine of not exceeding three hundred ringgit.

Parking spaces

- 6.—(1) A parking place may be divided into parking spaces and for the purpose of determining the parking spaces, the Commission shall cause each parking space to be indicated by painted lines, studs, signs or other indications.
- (2) There shall be erected at a parking place a sign or signs for the purpose of indicating parking spaces for the parking of a certain class or description of vehicle, and stating the prescribed fee and parking period imposed, if any.

Method of parking

- 7.—(1) No person shall park a motor vehicle in a parking space across any line marking the parking space or in such a position that the said vehicle shall not be entirely within the area delineated as parking space.
- (2) A person parking a motor vehicle in a parking space shall, subject to paragraph (1), cause such vehicle so far as the lines marking the parking space permit to face the general direction of traffic and shall conform to all signs and signals exhibited in such parking place.
- (3) Where any motor vehicle is parked in a parking space in contravention of the foregoing provisions, a parking warden may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions, and the driver or person in charge of such vehicle shall comply with such lawful instructions as a parking warden or a police officer in uniform may issue in order to comply with the provisions of this article.

Parking without the display of coupon

8.—(1) No person shall park or cause or permit to be parked any motor vehicle in any parking place specified in the First and Second Schedules without displaying on the motor vehicle in the manner prescribed by paragraph (1) of article 10 valid coupons prescribed by this Order having a value sufficient to meet the prescribed fee for the period during which the said vehicle is parked or to be parked in such parking place.

(2) A parking coupon in Form A, Form B, Form C or Form D, as may be appropriate, in the Third Schedule may be used in respect of any parking place specified in the First and Second Schedules.

Irregular and invalid coupon

- 9.—(1) No person shall display or cause or permit to be displayed on a motor vehicle any parking coupon that has any alteration, erasure or other irregularity therein which indicates that the coupon has been tampered with.
 - (2) A parking coupon shall not be valid if-
 - (a) the coupon is so torn, defaced or mutilated that the figures or other particulars therein are not legible;
 - (b) the period of validity of the coupon has expired; or
 - (c) the coupon does not indicate the date and time of commencement of parking the motor vehicle in accordance with paragraph (2) of article 10.

Manner of displaying coupon

- 10.—(1) As soon as motor vehicle is parked in a parking place, the driver of the motor vehicle shall display one or more coupons either on the offside of the front windscreen or the offside front window of the motor vehicle in such a manner that the coupon is clearly visible from the front or offside of the vehicle and the coupon shall have the date, time of commencement of parking of the said vehicle and other particulars indicated therein in accordance with paragraph (2).
- (2) The date and time of commencement of parking a motor vehicle in a parking place shall, where required to be indicated in the coupon by this Order, be indicated in the coupon in accordance with the instruction given in the form in which the coupon is set out in the Third Schedule.
- (3) No person shall display or cause or permit to be displayed on a motor vehicle a coupon in which the time of commencement of parking indicated thereon is later than the actual time when he parks the said vehicle.
- (4) Where two or more coupons are displayed on a motor vehicle to cover the period during the which such vehicle is to be parked in a parking place, the time of commencement indicated in the second and subsequent coupon or coupons shall run immediately after the time of expiry of the period of parking indicated in the coupon of the prior period of parking.
- (5) Any person who continues to park or causes or permits to continue to be parked any motor vehicle in a parking place after the expiry of the

period in respect of which coupons are displayed on the motor vehicle to meet the prescribed fee shall be guilty of an offence.

Issuance of coupons

11. The Commission or any person authorized by it may issue to any person a coupon or coupons upon payment of the appropriate fees.

Refund of unused coupons

12. No refund shall be allowed for any unused coupon except in such special circumstances as the Commission may allow and provided that the coupons are not defaced, mutilated or in any other manner invalid.

Production of coupon

- 13.—(1) The parking warden or any person authorized by the Commission may for the purposes of this Order require any driver of a motor vehicle parked in any parking place to produce for his inspection any parking coupon or coupons displayed on such vehicle and may retain any such parking coupon.
- (2) If the driver of the motor vehicle fails to produce the parking coupon or coupons displayed for inspection or retention by the Commission or any person authorized on its behalf, he shall be guilty of an offence.

Vehicles exempted from payment of fees

- 14.—(1) Subject to paragraph (5) of article 3, the undermentioned vehicles are exempted from the payment of parking fee—
 - (a) bicycles, tricycles and handcarts;
 - (b) two-wheel motor vehicles;
 - (c) such other classes or description of vehicles as the Commission may exempt in appropriate cases.
- (2) The exemption from the payment of parking fee in respect of any class of the vehicles mentioned in paragraph (1) may be withdrawn by the Commission as it deems proper.

Safety of other vehicles

15. No vehicle shall be drawn, driven or pushed within a parking place otherwise than in an orderly and careful manner and with due regard to the safety of other vehicles and persons within the parking place.

Unattended vehicles

16. No motor vehicle in a parking place shall be left unattended unless it is rendered immovable by the application of brakes or by some other sufficient means.

Suspension of use of parking places or spaces

- 17.—(1) The Commission may suspend the use of a parking place or space wherever it considers such suspension to be reasonably necessary—
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition, or excavation adjacent to the parking space or the maintenance, improvement or reconstruction of the parking space or the laying, erection, alteration or repair in or adjacent to the parking space of any sewer or of any cable, pipe, main or apparatus of the supply of water or electricity or of any telegraphic line;
 - (c) for the convenience of occupiers of premises adjacent to the parking space on any occasion for the removal or delivery of furniture from or to any such premises;
 - (d) on any occasion on which it is likely by reason of some special attraction that any road will be throughd or obstructed;
 - (e) for the convenience of occupiers of premises adjacent to the parking space at the time of wedding or funerals or other special occasions;
 - (f) for any other reason as the Commission may think fit.
- (2) On any suspension aforesaid the Commission shall cause to be affixed an appropriate notice at or near the parking place or space in question, and it shall be unlawful for any person to park any motor vehicle in such parking place or space except in relation to a purpose for which the suspension was made.

Reserved parking spaces

18. On the application of any person, firm, company, institution or organizations, the Commission may, at its own discretion, reserve parking spaces for such person, firm, company, institution or organization at a charge to be prescribed and subject to such conditions as may be imposed by the Commission from time to time.

Vehicles exempted

- 19. This Order shall not apply to-
- (a) any ambulance or any fire engine or any vehicle of the Armed Forces of the Federation, Visiting Forces or Police when used on official duty;
- (b) any vehicle on active service of any authority authorized by or under any written law, or under any order having the force of any written law, to construct, erect or carry on electricity, water or other public undertaking, in so far as such vehicle is being used actively in the construction, erection or carrying on of the undertaking; and
- (c) a vehicle which has been directed to a parking space by a police officer in uniform in the course of his duty.

Obstruction and removal

- 20.—(1) No person shall—
- (a) place or cause to be placed any goods or other objects on any parking space or on any part of a road adjacent to any parking space; or
- (b) park or cause to be parked any vehicle on any part of a road adjacent to any parking space;
 - (c) in such manner as to cause obstruction to the parking space:

Provided that this provision shall not apply—

- (i) to any vehicle stopping only for such time as is reasonably necessary to take up and set down passengers or load or unload goods; or
- (ii) to any goods or objects placed at the aforesaid places only for such time as may be absolutely necessary for the loading or unloading of such goods or objects.
- (2) A parking warden or any person authorized by the Commission may remove any vehicle, goods or object which is the cause of any obstruction aforesaid or in respect of which there has been a contravention or non-compliance with any of the provisions of this Order; and the owner of such vehicle, goods or object may within twenty-one days of such removal or detention reclaim from the Commission possession of such vehicle, goods or object upon payment to the Commission of the cost of removal and custody of the vehicle, goods or object.

- (3) Any unauthorized person removing or causing to be removed such vehicle, goods or object from the place of custody shall be guilty of an offence.
- (4) The Commission may at any time, if the goods or object aforesaid is of a perishable nature, and after twenty-one days in any other case, dispose of the goods or object and shall refund the proceeds thereof to the owner less the cost mentioned in paragraph (2) and any other cost incurred in connection with the disposal; and in the event that the owner of the goods or object is not ascertainable, the proceeds mentioned may after twelve months of the disposal be credited to the revenue of the Commission.
- (5) The Commission and his officers shall not be liable for any damage caused to the vehicle, goods or object in the course of its removal and while in the custody of the Commission.

Removal and detention by Commission

- 21.—(1) If for any reason a motor vehicle has been left in a parking place without displaying thereon valid coupons or after the expiry of the period indicated in the coupons, the Commission may cause the vehicle to be removed from the parking place to be detained by the Commission and shall not be released until all charges for the removal and detention of the motor vehicle as may be prescribed shall have been paid to the Commission.
- (2) The Commission and its officers shall not be liable for any damage to the motor vehicle or for any loss or damage to the fittings or contents of any motor vehicle so removed and detained by the Commission under this article.

Notification of removal and detention

22. When an object or a motor vehicle is removed or detained in pursuance of the provisions of article 20 or 21, the Commission shall with all reasonable dispatch give notice in writing to the owner thereof, if the name and address of such owner be known, of the removal or detention of such object or motor vehicle.

Prohibition of trade or business

23. No person shall use any motor vehicle parked in a parking space for the purpose of carrying on any trade or business.

Prohibition of repairs

24. No person shall repair a vehicle or permit a vehicle to be repaired in a parking place except in cases where minor repair is necessary to enable the vehicle to be removed from the parking place.

Prohibition of washing or cleaning

25. No person shall wash or clean or cause or permit to be washed or cleaned any vehicle in a parking place.

Solicitation for employment

- 26.—(1) No person shall solicit employment as a watchman at a parking place or for a parked vehicle.
- (2) No person shall loiter at or near a parking place for the purpose of obtaining employment as a watchman for a parked vehicle.

Removable of receipt or advice note prohibited

27. No person other than the person authorized by the Commission shall remove or cause to be removed any notice issued by a parking warden and affixed to the windscreen or any conspicuous part of a motor vehicle while being parked in any parking place or space.

Provision of signboards

28. The Commission shall provide a signboard or signboards at each parking place indicating the period during which motor vehicles or any particular class or type of vehicles may enter or use the parking place and stating the prescribed fee to be paid and may erect such signs and signals as may be considered necessary for the direction or regulation of vehicles within the parking place.

Emergency

29. In the case of any emergency, any person authorized in that behalf by the Commission or any police officer in uniform, may move or cause to be moved to any place he thinks fit any motor vehicle left in any parking place.

Penalty

30. Any person who contravenes any of the provisions of this Order shall be guilty of an offence: Penalty a fine not exceeding three hundred ringgit and in addition there shall be paid to the Commission all outstanding parking fees and charges due and payable under this Order.

Registered owner's liability

31. In cases of contravention of or failure to comply with any of the provisions of this Order, the registered owner of the vehicle shall be presumed to have contravened or failed to comply with such provision if the person (not being the registered owner) who actually contravened or failed to comply with such provision is not known or cannot be found.

Commission not liable for loss or damage

32. The Commission and its officers shall not be liable for any loss or damage to any vehicle or the fittings or contents of any vehicle parked in any parking place.

Conduct of prosecution

33. Prosecution of any offence under this Order may be conducted by the Public Prosecutor or any person duly authorized in writing by him pursuant to section 377 of the Criminal Procedure Code [Act 593].

Revocation

- 34.—(1) The following Orders are revoked—
- (a) the Kuching Municipal Council (Parking) Rules, 1976 [Swk. L.G. 37/76], in so far as they are applicable to the City of Kuching North by virtue of section 13(1)(a) of the City of Kuching North Ordinance, 1988 [Cap. 49], other than rules 28 to 31 of those Rules;
- (b) the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 1991 [Swk.L.N. 73/91];
- (c) the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 1993 [Swk. L.G. 43/93];
- (d) the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 1995 [Swk.L.G. 38/95];
- (e) the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 1997 [Swk. L.G. 72/97];
- (f) the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 2002 [Swk. L.G. 33/02];
- (g) the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 2004 [Swk.L.G. 33/04].

Saving

35.—(1) Nothing in this Order shall affect the past operation of, or anything done under, the Rules or Orders revoked pursuant to article 34:

Provided that any right, priviledge, proceeding or liability existing at the date of commencement of this Order by virtue of the revoked Orders, shall be subject to this Order.

- (2) Any rule, order, direction, notices or notification made, issued or given before or after the commencement of this Order, under the revoked Orders shall, if it could have been made, issued or given under any corresponding provision of this Order, as if it had been so made, issued or given, as the case may be.
- (3) Any proceeding, action, claim or liability made, instituted, filed, commenced or incurred under the revoked Orders prior or to the date of commencement of this Order, shall be deemed to be continued or have been incurred as if this Order has not been enacted.
- (4) Nothing in this Order shall affect any person's liability to be prosecuted or punished for offences committed, or to be sued for any outstanding parking fees or charges due and payable, by him under the revoked Orders before the coming into operation of this Order.
