### THE KUCHING MUNICIPAL ORDINANCE

THE KUCHING MUNICIPAL COUNCIL (LICENSING OF MISCELLANEOUS OCCUPATIONS) BY-LAWS, 1961.

#### (Made under section 100)

Cap. 116.

Pursuant to section 102 of the Kuching Municipal Ordinance, the Governor has approved the following By-laws made by the Kuching Municipal Council in exercise of the powers conferred upon the Council by section 100 of that Ordinance and in compliance with the provisions of section 101 thereof—

- 1. These By-laws may be cited as the Kuching Municipal Citation Council (Licensing of Miscellaneous Occupations) By-laws, 1961, and comand shall come into force on the 1st day of June 1961.
- 2.—(1) Any person who carries on any of the trades or Licences businesses specified in the First Column of the First Schedule in respect except under and in accordance with the provisions of a licence of certain issued by the Council and at the place, if any, specified in trades or the licence shall be guilty of an offence: Penalty, a fine of fifty dollars for the first offence, and in the case of a second or subsequent offence, a fine of one hundred dollars.
- (2) There shall be payable in respect of licences to carry on the trades and businesses referred to in paragraph (1) the appropriate fees set out in the Second Column of the First Schedule.
- 3.—(1) Any person who sells alcoholic liquor except under Licences and a accordance with the provisions of a licence issued by the to sell Council and at the place specified in the licence shall be guilty alcoholic of an offence: Penalty, a fine of one hundred dollars for the liquor. first offence, and in the case of a second or subsequent offence, a fine of one hundred and fifty dollars.
- (2) There shall be payable in respect of the licences to sell alcoholic liquor specified in the First Column of the Second Schedule the appropriate fees set out in the Second Column of that Schedule.
- (4)—(1) Licences may be issued on the payment of the appro-Perical of printee fee and shall—
  - (a) in the case of a yearly licence expire on the 31st and day of December; and
  - (b) in the case of a quarterly licence expire on the 31st day of March, the 30th day of June, the 30th day of September or the 31st day of December, whichever first comes after the date of issue.
- (2) Any yearly or quarterly licence renewed within forty-two days of the date of expiry shall be deemed to be renewed with effect from the date of expiry.

Revocation. 5. By-laws 1 and 2 of Chapter 4, the whole of Chapter 7 and by-law 2 of Chapter 12 of the Kuching Municipal By-laws are revoked.
