THE ROAD TRANSPORT ACT 1987

THE ROAD TRANSPORT (PROVISION OF PARKING PLACES)
(CITY OF KUCHING NORTH) (AMENDMENT) ORDER, 2018

(Made under order 3)

In exercise of the powers conferred by order 3 of the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 2005 [*Swk. L.G. 48/2005*] (hereinafter referred to as "Principal Order"), the Commission of the City of Kuching North, has made the following Order:

Citation and commencement

1. This Order may be cited as the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 2018, and shall be deemed to have come into force on the 1st day of January, 2018.
